

The Residential Services Housing Contract ("Contract") establishes an agreement between Northwestern University ("University") and the student ("Student") for use of assigned space and facilities of a residence for and in consideration of the keeping and performing by Student of all understandings, agreements, terms and conditions of obligation enumerated herein.

The Contract does not guarantee assignment to a particular type of accommodation (room or apartment) or assignment to any preference indicated by Student. Student's preferences are requests only; preferences for room or apartment type, building of occupancy and University's granting of roommate requests cannot be guaranteed. The Contract does not determine final admission of the Student to the University. Assignment to campus housing is contingent upon

the University's final acceptance of the Student's application for admission to the University for the following academic year.
